# How to protect yourself

We strongly advise you to only deal with financial firms that are authorised by us, and check the <u>Financial Services Register</u> [1] to ensure they are. It has information on firms and individuals that are, or have been, regulated by us.

If a firm does not appear on the Register but claims it does, contact our Consumer Helpline on 0800 111 6768.

There are more steps you should take to avoid scams and unauthorised firms [2].

If you use an unauthorised firm, you won't have access to the <u>Financial Ombudsman Service</u> [3] or <u>Financial Services</u> <u>Compensation Scheme</u> [4] (FSCS) so you're unlikely to get your money back if things go wrong.

If you use an authorised firm, access to the Financial Ombudsman Service and FSCS protection will depend on the investment you are making and the service the firm is providing. If you would like further information about protection, the authorised firm should be able to help.
